Program Description: This program is designed to provide an accounting curriculum for those students whose primary interests lie in the area of accounting, but who do not plan to work towards a four-year degree or become an accounting technician. This will be accomplished through providing a core curriculum of courses designed to impart a general theoretical and practical knowledge of accounting, and allowing the student discretion in selecting additional accounting and related courses.

Note: In order to be granted the Associate of Applied Science Degree in Accounting, the student must maintain a 2.0 or better average for all accounting courses taken. Basic computer skills utilizing word processing, spreadsheet, and presentation software are recommended for all accounting courses.

Students interested in transfer should always contact ACC counselors and consult with an advisor or articulation officer from their receiving institution.

Final approval of the degree plan for graduation is provided by the Admissions Office. Application for graduation must be on file in the Admissions Office before the published deadline of the student's final semester. The ACC Catalog contains important information about graduation.

Example positions available in Accounting Tax Specialist include Bookkeeping, Tax Preparation, and Payroll Services.

Tax Preparers: New workers generally start around \$31,268. Normal pay for Tax Preparers is \$47,986 per year, while highly experienced workers can earn as much as \$75,562.
